



TERMS OF USE

I. YOUR ACCEPTANCE

By using, visiting, and/or contributing any material to this website (www.centerforsacredstory.com) whether in written, recorded, or filmed formats, YOU SIGNIFY YOUR ASSENT TO BOTH THESE TERMS AND CONDITIONS (the "Terms of Service") AND THE TERMS AND CONDITIONS OF THE CENTER FOR SACRED STORY PRIVACY NOTICE WHICH ARE INCORPORATED HEREIN. If you do not agree to any of these terms, then please do not submit any material.

2. CENTER FOR SACRED STORY WEBSITE

THE INFORMATION CENTER FOR SACRED STORY COLLECTS

User Provided Information: You provide certain personally identifiable information (such as your name and email address) to Center for Sacred Story when choosing to participate in various activities on the Center for Sacred Story Sites such as uploading audio files (MP3s) videos, posting messages in our forums or in the video comments

section, entering contests or sweepstakes, taking advantage of promotions, responding to surveys, or subscribing to newsletters or other mailing lists.

Cookies Information: When you visit the Center for Sacred Story Sites, we may send one or more cookies - a small text file containing a string of alphanumeric characters - to your computer that uniquely identifies your browser.
